INFORMATION AND APPLICATION FOR BRIDGING THE GAP: TRAINING OF MEDICAL INTERPRETERS

Becoming a Medical Interpreter

Are you interested in a career in healthcare that uses your bilingual and bicultural skills? Here is a great training opportunity for you!

For more than 17 years, the Utah Department of Health has trained bilingual and bicultural individuals on how to become effective medical interpreters. We use the *Bridging the Gap Medical Interpreter Training*, a nationally recognized training course from the Cross Cultural Health Care Program.

Bridging the Gap (BTG) is a 64-hour professional development program that prepares bilingual individuals to work as medical interpreters. BTG is used to train both novice and experienced medical interpreters, and is the first step towards national certification. Both accredited national certifying bodies, the Certification Commission for Healthcare Interpreters (CCHI) and the National Board of Certification for Medical Interpreters (NBCMI), accept BTG.

Description of the Program

This 64-hour professional training is provided in English over a period of three weeks. The course covers:

- **Basic Interpreting Skills.** Roles, ethics, conduit and clarifier interpreting, managing the flow of the session, intervening, sight translation, and memory development.
- **Codes of Ethics.** Codes of ethics and decision-making for interpreters in healthcare.
- **Integrated Medical Terminology, Anatomy, and Physiology.** Introduction to medical terminology, common terms, common health problems, basic medical procedures, and specialties relating to human anatomy/physiology and health.
- **Healthcare Systems.** Introduction to the healthcare systems and types of health care providers.
- **Culture in Interpreting.** Self-awareness, basic characteristics of specific cultures, traditional healthcare in specific communities, and culture brokering
- **Communication Skills for Advocacy.** Listening skills, communication styles, how doctors think, and appropriate advocacy
- **Professional Development.** Effective communication, professional conduct, self-care, and resources for professional growth

After successful completion, participants will receive a certificate of completion for 64-hour Professional Medical Interpreting training. This certificate may be used to provide proof of professional training to employers and meet educational requirements towards state or national certification programs.

Cost of the Training

This training is **FREE** to individuals that submit a completed application and meet the minimum requirements.

All training books and materials are provided at no cost to those that complete the course.

Admission Requirements

All applicants must meet the following minimum requirements, provide proof of language proficiency, and submit a completed application packet.

Minimum requirements:

- Sponsorship by a not-for-profit organization
- Be 18 or older and have a high school diploma or equivalent
- Resume or Curriculum Vitae describing your experience with medical interpreting
- Proof of language proficiency: participants must be bilingual in English and at least one other language. Proof of proficiency in English and other language may include one of the following for each language:
 - High school diploma or equivalent, or university/college degree from a school using the assessed language(s)
 - Five or more years of verified professional experience working in the language(s) being assessed (as demonstrated in resume or CV)
 - State or federal court interpreter certification
 - Oral language exam results with scores equivalent to ACTFL Advanced Mid-level or ILR Level 2

Training Hours and Location:

This 64-hour professional training will be taught in Salt Lake City in nine daily sessions beginning Thursday, August 1 through Friday, August 30, 2019. Please see schedule below.
